_____ Beneficiary or his/her legal representative agrees not to submit a claim to Medicare or to ask the doctor to submit a claim to Medicare.

_____ Beneficiary or his/her legal representative understands that Medicare payment will not be made for any items or services furnished by the doctor that would have otherwise been covered by Medicare if there was no private contract and a proper Medicare claim had been submitted.
